**310 (casual workers are excluded)**
2. From such overall total, how many were employed full time and how many were employed part time?  
**242 full-time**  
**68 part-time**
3. What was the total annual amount paid in salaries to persons employed by IOM Post office as at 31st March 2022?  
**£9.765M (all gross payments and not exclusive to basic salary, including casual workers and board members)**

In response to an application for review, the Information Commissioner may, at any time, attempt to resolve a matter by negotiation, conciliation, mediation or another form of alternative dispute resolution and will have regard to any outcome of this in making any subsequent decision.
