### **IMS – Customer Survey**

#### **Isle of Man Post Office - Data Controller**

Isle of Man Post Office (IOMPO) is a data controller for the purposes of the General Data Protection Regulation (Isle of Man) Order 2018. The contact details for the IOMPO are Isle of Man Post Office, Postal Headquarters, Spring Valley Industrial Estate, Douglas, Isle of Man IM2 1AA.

In addition to the information set out in the IOMPO privacy notice, we may also collect the following information about you:

- Name of person submitting survey
- Company name
- Company address
- Email address of person/company submitting survey
- Phone number of person/company submitting survey

#### **How we will use the information, we collect about you**

IOMPO will use your information to:

- seek feedback on services provided by the Integrated Mailing Solutions Division (IMS) to fulfil our ISO accreditation obligation to monitor and respond to customer feedback
- process the prize
- verify the information and documentation you have provided is correct
- publish the winner's name and photograph

The survey can be completed anonymously or contact details can be provided for the purpose of participating in the prize draw (please see [Customer Satisfaction Survey – Prize Draw terms and conditions](#) for full details of the draw)

#### **How we will share the information we collect about you**

Third parties we may share your data with are:

- SurveyMonkey – to allow us to obtain feedback on our service

#### **Protecting your information**

Isle of Man Post Office will:

- keep your information safe and secure in compliance with its information security and data protection policies
- only use and disclose your information as detailed above, where necessary
- only authorised staff are able to view your data
- retain the information for no longer than is necessary and your information in connection with the survey will be permanently deleted once the timeframes set out below have been reached.

#### **Transfer of information outside the EEA**

SurveyMonkey may require data to be stored on servers outside of the EEA. Information sent to these will be limited and are as detailed above.

Where your personal data is transferred outside the EEA, we will ensure that it is protected in a manner that is consistent with how your personal data will be protected by us in the EEA. This can be done in a number of ways, for instance:

- the country that we send the data to might be approved by the European Commission or a relevant data protection authority;
- the recipient might have signed up to a contract based on “model contractual clauses” approved by the European Commission, obliging them to protect your personal data

In other circumstances the law may permit us to otherwise transfer your personal data outside the EEA. In all cases, however, we will ensure that any transfer of your personal data is compliant with data protection law.
