## **Notes**

If you have the new style (A4 size) Vehicle Registration Certificate for your vehicle (not the yellow log book), this document should be acceptable for re-registering in any European Union Country and you may not need an 'Export Certificate'. If you are exporting your vehicle to a non European Union country it is recommended that you obtain an Export Certificate.

It is advisable that you confirm with the country that the vehicle it is being exported to whether an Export Certificate is required.

This application form is used to notify the Post Office that the vehicle has been exported to outside of the Isle of Man and should not be used for any other purpose.

If you wish to retain the registration number then use a C1 form or MVR2 form to move the number onto another vehicle.

If the vehicle has a valid licence disc then this can be submitted using an R1 form for a refund of any full months remaining at the time of application.

If an export certificate is required then submit the Vehicle Registration document with this form and follow the procedures below.

Please be aware that once a vehicle has been issued with a Certificate of Export or declared as exported, the registration and licence (tax disc) of the vehicle is no longer valid.

### **Payment Methods for Export Certificate if Required**

Please make cheques payable to Isle of Man Post Office. All postal applications must be made by cheque or postal order and not cash. Payment at the Post Office counters may be paid by: Cheque, Cash, Debit Cards or Postal orders.

#### **Fees**

Export Certificate £8.00 Emergency transactions will incur a further £23.00 fee

#### **Permanently Exporting a Vehicle**

Taking your vehicle abroad for more than 12 months (permanent export)
If you are taking your vehicle off the Island on a permanent basis you must notify the Post Office of the vehicle's export. And re—register the vehicle in the new Country of residence.

#### Temporary Export (taking your vehicle off Island for less than 12 months)

If you are taking your vehicle off the Island for less than 12 months you must make sure you take your Vehicle Registration Certificate (log book) with you. You should make sure that you meet any international and national conditions for licensing and taxation.

#### **Re-Registration Testing requirement Information**

Vehicles that have been registered elsewhere and then brought back into the Isle of Man that are over 3 years old will require to be tested prior to re-registration here.

Vehicles that have been exported or declared exported but not registered elsewhere and then brought back into the Island may require to be verified or tested at the Vehicle Test Centre Tromode. Vehicle test centre number 627431.
